By placing an order, you are forming a legally binding contract with Natasha Adams Design, for products and services, and you agree to be bound by the following Terms and Conditions.

CUSTOMERS

Individuals placing this order in the name of a company agree they are legally authorised to place this order on the company's behalf.

PRICING and QUOTATIONS

Prices published by Natasha Adams Design are subject to change without notice. Every effort will be made to notify clients of price increases in advance. Written quotations will be honoured for 30 days from the quote date. All prices, unless otherwise specifically stated, are exclusive of GST.

REVISIONS and ALTERATIONS

All prices quoted are inclusive of three minor alterations. Any major, or any subsequent minor alterations will be charged at the standard hourly rate. Natasha Adams Design shall be the sole arbiter of what constitutes a major or minor alteration, and this determination shall be conveyed to The Client as soon as it becomes apparent.

COMPLAINTS

All complaints must be made within 5 business days of receipt of the job. Orders with manufacturing errors and/or defects will be re-run on the next print run at no charge to The Client. Unsatisfactory orders as a result of client errors may, at the sole discretion of Natasha Adams Design, be reprinted at a reduced rate.

ERRORS and OMISSIONS

Natasha Adams Design is not responsible for errors and omissions which are contained in work which has been initially proof read and approved by The Client. The Client is solely responsible for errors missed during the proofing process of either artwork supplied by The Client for printing or artwork created by Natasha Adams Design.

INDEMNIFICATION

The Client will indemnify and hold harmless Natasha Adams Design from all and any loss, expense or damages arising out of violation of copyright or trademark laws from the illegal use of images, photographs, slogans, trademarks, or graphical work supplied by The Client.

DELIVERY and SHIPPING

All turnaround times are approximate and although every effort is made to meet these delivery times, we will not be liable for any costs or damages resulting from deliveries made later than expected to The Client.

TERMS OF SALE

Accepted payment methods are cash, personal and company cheques and funds transfer.

All orders require a 30% deposit upon placing an order with balance being COD.

In the event that a personal or company cheque is returned for non-sufficient funds, The Client will be required to pay a \$50.00 administration fee.

Accounts unpaid after 90 days from invoice date, will be placed with a collection agency without further notice and an administration fee of \$75.00 will be charged to The Client.

In the event of non-payments that lead to dispute and/or litigation, The Client agrees to pay all legal and collection fees incurred.

All goods, intellectual property, licenses and associated rights will remain the property of Natasha Adams Design until paid for in full.
